# Idea Cellular offers 1,865 Pols to Reliance Jio

fe Bureau

New Delhi, Sept 23: Idea Cellular on Friday said it has more than tripled the Points of Interconnection to new entrant Reliance Jio Infocomm by offering 1,865 interconnect points compared to its earlier provisioning of 565 points, in a bid to improve the quality of service for phone calls and after a mutual meeting to resolve asymmetry in traffic between the two operators.

The current capacity provided is more than Reliance Jio's initial demand of 1250 points.

"With this huge capacity expansion, over 2,100 ports will now be available for traffic between Idea and Jio, allowing sufficient buffer for the future," Idea said in a statement. The country's third-largest operator is also expanding its national long distance capacity that allows making STD calls by users by 50%, it said.

Idea Cellular, on September 12, provided 196 more Pols to support capacity of 6.5 million users of Re-

liance Jio, followed by Vodafone India which said it will triple the Pol capacity late last week giving 585 Pols as against Reliance Jio's demand of 1,590 points. Also the development comes days after Bharti Airtel's chairman Sunil Mittal said his com-

pany would provide 1000 more Pols, adding 1900 points compared to 2200 points as demanded by Reliance Jio.

Meanwhile, Reliance Jio Infocomm said the proposed augmented capacity is less than 40% of its initial demand, while complaining of 4 crore call failures between the two operators. "Adequate interconnection capacity so that call failure rate is less than 5 per 1,000 is a licence obligation of all telecom operators," Reliance Jio said in a statement.

# Festive season may help e-commerce players hit \$18-20 bn annual turnover

Chennai, Sept 23: The forthcoming festive season sale by e-commerce companies such as Flipkart, Amazon, and Snapdeal in the first week of October could take the annual turnover of the industry this year to \$18-20 billion but is unlikely to see any deep discounting, according to a report.

In the backdrop of Department of Industrial Policy & Promotion (DIPP) guidelines barring discounts and capping total sales from a single vendor to 25%, RedSeer Consulting said this year e-tailers could still get a winning edge by allocating the limited discounting and advertising budget in a targeted way.

"With the new directives from the

Department of Industrial Policy and Promotion (DIPP) of capping total sales originating from a group company or one vendor at 25%, India's fundamentally strong e-tailer market could not foray into aggressive discount schemes. With this festive season I foresee a spring effect of targeted marketing and focus on quality customer segments. It is going to be a win-win situation for online shoppers," said Anil Kumar, CEO RedSeer Consulting.

RedSeer said in 2016 e-tailers will have to allocate the limited discounting and advertising budget in a targeted way and prioritise specific stock keeping units (SKUs) and high demand product categories.
