On Kargil Vijay Diwas PM...

Gate here. Indian and Pakistani armies fought the Kargil War in May-July 1999 in the Kargil district of Kashmir and elsewhere along the Line of Control (LoC). India launched 'Operation Vijay' to clear the Kargil sector of infiltration by Pakistani soldiers and Kashmiri militants on the Indian side of the Line of Control. On July 26, 1999, India successfully retook the high outposts lost to Pakistani intruders to end the Kargil War. The nearly week-long 17th Kargil Vijay Diwas celebrations began under the aegis of the Army's Fire and Fury Corps on July 21. Army Chief General Dalbir Singh paid homage to the martyrs of 'Operation Vijay' at the historic Kargil War Memorial at Drass in Kargil district of Jammu and Kashmir on Monday.

on his date of appointment, etc. The minimum monthly salary of a Central Government employee has been fixed at Rs 18,000 from earlier Rs 7,000. The maximum will now be Rs 2.5 lakh for the Cabinet Secretary, which is more than double the current pay of Rs 90,000 a month for the country's top bureaucrat. For other officers in the top scale -- secretary or equivalent -- the monthly salary will now be around Rs 2,25,000. Meanwhile, non-performing Central Government employees will not get annual increment if their performance is not upto the mark, the Centre has said. The benchmark for performance appraisal for promotion and financial upgradation has been enhanced to "very good" from "good" level, the Finance Ministry said in an order notifying implementation of Seventh Central Pay Commission's recommendations. The Modified Assured Career Progression (MACP) scheme will continue to be administered at 10, 20 and 30 years of service as before, the Ministry said as it "accepted" the pay panel's recommendations. The Centre will set up anomalies committees to examine individual, post and cadre-specific anomalies arising out of implementation of the recommendations of seventh Central Pay Commission. The Department of Personnel and Training (DoPT) has been authorised to take action regarding pay and related issues concerning officers of all India services--Indian Administrative Service (IAS), Indian Police Service (IPS) and Indian Forest Service (IFS). 'NOT APPROPRIATE TO COMPARE 7TH PAY PANEL WITH PREVIOUS ONES': THE Government on Tuesday said it is "not appropriate" to compare the increase in minimum pay suggested by the 7th Central Pay Commission with that of the previous commissions. According to the 7th Pay Commission, the real increase given in 1996 and 2006 in minimum pay was 31 per cent and 51 per cent. As compared to that, the commission recommended an increase of 14.29 per cent. "The 7th Central Pay Commission has worked out its recommendations on pay based on all relevant factors having a bearing on the prevailing circumstances and, therefore, viewing the increase on this occasion in the light of the circumstances obtaining 10 and 20 years ago is not appropriate," Minister of State for Finance Arjun Ram Meghwal said in a written reply to the Rajya Sabha. He further said that the ratio between the minimum pay of Rs 18,000 per month and pay of Rs 2,25,000 per month in the apex grade works out to be 1:12.5. "In order to enhance the income of other categories of workers, both central and state governments are required to fix, review and revise the minimum wages of the workers employed in scheduled employment under their respective jurisdictions at an interval not exceeding five years. "The minimum rate of wages are also applicable for the workers engaged on contract basis," he said while replying to another question.

A fleet of ambulances, police cars and fire trucks converged on the Tsukui Yamayuri-en centre, a low-rise building nestled against forested hills, which was cordoned off and draped with yellow "Keep Out" tape. Fire department spokesmen told AFP that the dead included nine men and 10 women aged from 18 to 70, and that another 25 people were wounded, 20 of them seriously. An official from Kanagawa prefecture, which takes in Sagami-hara, identified the suspect and said he had turned up at the police station with the murder weapons. Uematsu "broke a glass window and intruded into the facility at about 2:10 AM and stabbed those staying there," Shinya Sakuma told a press conference in the prefecture's capital Yokohama. "When Uematsu turned himself in, he was found carrying kitchen knives and other types of knives stained with blood." The timeline of the attack remained unclear. Police earlier said they received a call from the centre around 2:30 AM, raising the alarm that a man armed with a knife had entered the facility. They said he turned himself in half an hour later. "I was shocked," said Chikara Inabayashi, 68, who lives near the care centre which takes in up to 160 residents. "I woke up at about 3 AM because of the blaring noise of the sirens," he told AFP. AAP to release 'Dalit Centre, State Govts make headway on key GST issues

NEW DELHI, July 26 (PTI)

AT A TIME assaults on Dalits have turned into a political hot potato, the Aam Aadmi Party has decided to launch 'Dalit Manifestos' in poll-bound Punjab, Goa and Gujarat to "expose the anti-Dalit and Manuwadi" side of BJP.

Party sources said that the manifestos, which would be specifically targeted at the Dalit community, will deliberate extensively on the "systemic oppression" against them in the States and the highlight the lack of an agenda to include them in the societal development.

AAP will also bring out a 'Youth Manifesto' in Goa like the one in Punjab.

"Since the Centre is not interested in taking any action against the perpetrators of crime against Dalits, then what options are left? In Gujarat,

it is not the first time that Dalits were beaten up so badly.

But how many people know that this has been going on?" a senior party functionary asked.

AAP believes that the "time has come" to "expose the anti-Dalit and Manuwadi" side of Bharatiya Janata Party (BJP), the leader said, adding that people should know that it does not have any inclusive agenda of which Dalits will be a part of.

"Why did they insult Mayawati?... I think the time has come that people should know that BJP is anti-Dalit. It's basically a Manuwadi party and it does not have any inclusive agenda to include Dalits in its developmental agenda," he said.

Delhi Chief Minister Arvind Kejriwal, who visited Gujarat twice in the recent past, had dubbed BJP as "anti-Dalit" and accused it of "trampling" upon the depressed sections after meeting the Dalit victims who were thrashed by cow vigilantes at Gir Somnath district for allegedly skinning a dead cow on July 11.

NEW DELHI, July 26 (PTI)

MAKING headway on the long-pending GST Bill, the Centre and States on Tuesday agreed on the principle that the tax rate will be lower than the current levels even as the broad consensus emerged that the rate should not be part of the statute.

A meeting of the Empowered Committee of State Finance Ministers convened by Finance Minister Arun Jaitley also agreed to include in the Constitutional Amendment Bill the mechanism of compensating States for any loss of revenue in first five years of Goods and Service Tax (GST) subsuming all indirect tax levies including VAT.

There was also broad agreement on the principle that the

ordinary businessman and the common tax man will benefit from introduction of GST by way of lower tax rates while the States will not face any loss of revenue, West Bengal Finance Minister and the panel chairman Amit Mitra said after the meeting. Also, there was "consensus to keep the GST rate out of the Constitutional Amendment Bill," he claimed.

The Government is keen to get the GST Bill approved during the current monsoon session of Parliament ending August 12 but is facing opposition from Congress which wants a low tax rate to be part of the Constitutional Amendment Bill while the one per cent additional tax in hands of States over and above the GST rate be scrapped.

"As you know that no tax rates are provided in the Constitution. It was discussed and conclusion reached that Union Finance Minister will communicate to other parties. He will explain it to them that it can't come in Constitutional Amendment but it can come in GST Bill or GST

Act," Mitra said. The "broad consensus put together is satisfactory to all political parties and all States," he said adding "fool proof" wording for compensation to States has been worked out.

There are indications that the Government may now bring the GST Bill in Rajya Sabha next week instead of earlier plans of doing it this week.

Mitra said while there was no talk on specific tax rate, it emerged at the meeting that the rate should be such that is lower than existing levels otherwise "there is no point of reform."

The States, he said, were of the view that small businesses with turnover up to Rs 1.5 crore in a year should come under purview of only State Governments and dual control of States and Centre can be exercised over businesses larger than them.

Once the Constitutional Amendment Bill is passed by Parliament by two-thirds majority, both the Houses will have to pass another Bill to implement the GST.

Court convicts RSPL, three officials in C'garh coal block scam case

Committee went to the Prime Minister (Manmohan Singh) as Minister-in-Charge, Coal, Government of India for final approval and thus it was primarily the Government which was deceived into making allotment of a coal block in favour of M/s RSPL while believing all such representation to be true, which in fact were not," Special CBI Judge Bharat Parashar said in his 107-page judgement. The court held the firm and its officials--Managing Director Pradeep Rathi, Chief Executive Officer Udit Rathi and AGM Kushal Aggarwal--guilty of offences of cheating (section 420) and criminal conspiracy (section 120-B) of the IPC in the case pertaining to irregularities in allocation of Kesla North coal block in Chhattisgarh to the firm.

After holding them guilty, the court heard the arguments on the quantum of sentence during which the CBI sought maximum sentence while the convicts prayed for leniency. The court, which took the convicted officials into custody, reserved its order on the quantum of sentence for Wednesday.

An offence under section 420 of IPC entails a maximum punishment of upto seven years

along with fine. In its verdict, the court noted that all the necessary ingredients of offence of cheating coupled with dishonestly inducing delivery of property was clearly proved beyond shadows of all reasonable doubts. "Ministry of Coal (MoC), Government of India clearly stood cheated on account of dishonest acts of accused persons resulting in allotment of 'Kesla North Coal Block' in favour of company of accused persons i.e. M/s RSPL," the court said. In the first conviction, the court had in April awarded a four-year jail term to Jharkhand Ispat Private Limited (JIL) directors R C Rungta and R S Rungta in a coal block allocation scam case. It had also imposed Rs five lakh fine on each of the convicts held guilty for deceiving and defrauding government to bag a coal block in Jharkhand. In Tuesday's verdict, the court added that "the accused persons hatched a criminal conspiracy so as to cheat MOC, GoI in order to procure allocation of a coal block in favour of M/s RSPL."

adjournments will be granted in the case after it commences the final hearing in the matter. During the hearing the counsel appearing for Tamil Nadu said, Jallikattu is a sport being practised for centuries and it showcases an age-old cultural practice in the State. The Supreme Court had on January 21 refused to re-examine its 2014 judgement banning use of bulls for Jallikattu events or bullock-cart races across the country. On Jan 8, the Centre had issued a notification lifting ban on Jallikattu in poll-bound Tamil Nadu with certain restrictions, which was challenged in the apex court by Animal Welfare Board of India, PETA India, a Bangalore-based NGO and others. The apex court had stayed this notification.

From Sharmila to...

Assembly elections in Manipur are scheduled early next year. In the past, many political leaders have met Sharmila and tried to cajole her into joining politics but she has rejected all offers. She also expressed her desire to get married after coming out of prison on August 9. The civil rights activist

is known to have a boyfriend, a British national of Indian origin, who has in the past been in trouble with Sharmila supporters. On the charge of attempting suicide by means of a fast unto death in 2006 at Jantar Mantar in New Delhi, she has been arrested, released and then re-arrested from time to time.

Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act is among the law's objectives. Briefing reporters after the meeting, Parliamentary Affairs Minister Ananth Kumar said, the Government is keen on the passage of the Compensatory Afforestation Fund Bill (CAMPA) and Benami Transactions (Prohibition) Amendment Bill in the coming days. The party leaders also paid rich tributes to the martyrs on the occasion of the Kargil Vijay Diwas on Tuesday. Kumar said five bills in Lok Sabha and two in the Rajya Sabha, which has seen frequent disruptions, have been passed so far in the ongoing Monsoon Session and appealed to the opposition in the Upper House to participate in the discussion.

WE 'WASTED' 25 YRS IN ALLIANCE, RUES UDDHAV: SHARPENING his attack on the BJP, Shiv Sena chief Uddhav Thackeray on Tuesday rued his party "wasted" 25 years being in alliance with it while asserting that his outfit will come out of the Government the moment it feels being "disregarded."

The Sena chief, in the third and final part of his interview to the party mouthpiece "Saamana", however, maintained that he would never blackmail or backstab the ally.


अमेरिकी विज्ञानियों के अध्ययन का निष्कर्ष अनिद्रा से बच्चे हो सकते हैं डिप्रेसन के शिकार

अनिद्रा को कई शारीरिक और मानसिक बीमारियों के लिए जिम्मेदार माना जाता है। खासकर बच्चों पर इसका व्यापक असर पड़ता है। अमेरिकी शोधकर्ताओं के मुताबिक अपर्याप्त नींद बच्चों में आगे चलकर डिप्रेसन या अवसाद का खतरा ज्यादा रहता है। ब्रूस्टन यूनिवर्सिटी में मनोविज्ञान के प्रोफेसर कैडिस अलफानो के मुताबिक पर्याप्त नींद बच्चों के स्वस्थ मानसिक विकास के लिए जरूरी है। लगातार अपर्याप्त नींद से डिप्रेसन, व्यग्रता और अन्य तरह की भावनात्मक समस्याएं होने की आशंका रहती है। शोध में शामिल सात से 11 वर्ष के बच्चों को अस्थायी तौर पर कम समय तक नींद लेने की छूट दी गई थी। बाद में किए गए परीक्षण में इनमें भावनाओं से जुड़ी समस्याएं पाई गईं। इसके अलावा सकारात्मक बातों की याद रखने में असमर्थता की बात भी सामने आई है। पर्याप्त नींद लेने वालों में इस तरह की दिक्कत देखने को नहीं मिली।



ट्रांसप्लांट के बाद भी किडनी रहेगी सुरक्षित

ट्रांसप्लांट या प्रत्यारोपित किडनी को अब किसी भी तरह के नुकसान से बचाना आसान होगा। अमेरिकी वैज्ञानिकों ने ऐसे अंतरों का पता लगाने का नया तरीका ईजाद करने का दावा किया है। उन्होंने ऐसे जीन का पता लगाया है जो प्रत्यारोपित किडनी में फाइब्रोसिस बीमारी का पूर्वानुमान लगाने में मददगार है। इसके चलते किडनी फेल होने की आशंका भी रहती है। शोधकर्ता बारबर मर्फी ने बताया कि किडनी को ट्रांसप्लांट करने के तीन महीने और 12 महीने के बाद बायोप्सी के नमूने लिए गए। माइक्रोएरे की मदद से क्रोमिक एलोग्राफ्ट डैमेज इंडेक्स (सीएडीआइ) की अधिकता वाले जीन का पता लगाया गया। माइक्रोएरे से जीन या प्रोटीन की मात्रा का पता लगाया जाता है। सीएडीआइ स्कोर से प्रत्यारोपित किडनी में फाइब्रोसिस के स्तर को मापा जाता है। शोधकर्ताओं के मुताबिक यह पहला मौका है, जब ट्रांसप्लांट किडनी में होने वाले नुकसान का पूर्व में पता लगाना संभव हो सकेगा।
